Sadie has a tendency to wander, lacks insight into risks around the house and can be unsettled during the night.

Two weeks ago the situation at home became critical with Sadie became highly distressed and lashed out at Jim. Sadie was admitted to hospital, she is currently in the local geriatric psychiatric unit for assessment but is ready for discharge.

Jim wants Sadie to return home but recognises that he needs more support. Sadie finds it hard to articulate her wishes but has always said she doesn't want to go into care and has not settled on the ward she frequently wanders and appears agitated.
