## Notes to this Notice of Extraordinary General Meeting

- a) All members are welcome to attend the Extraordinary General Meeting, but only office bearers and full members may vote.
- b) All members attending the Extraordinary General Meeting are required to sign the attendance sheet.
- c) No business shall be transacted at any general meeting unless a quorum is present; 10 full members present in person shall be a quorum.
- d) A resolution shall be decided on a show of hands.
- e) An "ordinary resolution" requires a majority vote (taking account only those votes cast in favour as compared with those votes cast against, and (as applicable) the President's casting vote).
- f) A "special resolution" requires 75% or more of the votes cast on the resolution to pass. For the avoidance of doubt, a 75% majority relates only to the number of votes cast in favour of the resolution as compared with the number of votes cast; no account shall be taken of abstentions or members absent from the meeting.
