Systems – Institutional Reform

Presentation Topic: The Public Records (Scotland) Act and records created by third party providers.

Tom Shaw, Chair of the Historical Abuse Systemic Review, (2007), concluded that Scotland's laws on records did not do enough to ensure that records relating to children's residential services were preserved and that people had access to them. Poor records management practices meant that records were missing, were erroneously destroyed or weren't generated in the first place.

Scottish Ministers acted to address this failing by passing the Public Records (Scotland) Act 2011, introduced in 2013. The Act seeks to help public authorities improve record keeping generally, but it specifically seeks to address records created by third party providers, such as private and third sector care providers. It does this by providing a definition of public records. Section 3 of the Act says,

In this Act, "public records", in relation to an authority, means—

- (a) records created by or on behalf of the authority in carrying out its functions,
- (b) records created by or on behalf of a contractor in carrying out the authority's functions.
- (c) records created by any other person that have come into the possession of the authority or a contractor in carrying out the authority's functions.

The Act does not, however, list third party providers under the Schedule of bodies that must comply with its requirements. The Keeper of the Records of Scotland (the Keeper), who must implement and regulate the Act, has no statutory authority to direct third party providers. How then do we ensure this clause will succeed in its aim?

The session will explore how the Keeper's assessment team worked with Scottish public sector records and information specialists to co-produce an agreed approach to this challenge and to jointly develop guidance. It will consider how stakeholders, five years after the Act was introduced, seized the opportunity to further highlight this important part of the Act under revised statutory guidance. This clearly demonstrated the central nature of this issue to colleagues and the success of the Act, but also the extent to which they have taken ownership of the Act and will direct its future. It will also consider challenges and outstanding issues and will ask whether, for example, eight years after the introduction of the Act, it remains appropriate for the Keeper not to engage directly third party providers?
