### Notes to this Notice of Annual General Meeting

- a) The complete Memorandum and Articles of Association (November 2019) are available on the Social Work Scotland website.<sup>1</sup>
- b) All members are welcome to attend the Annual General Meeting, but only Ordinary and Executive Members may vote on resolutions and the election of Directors. Other polls may be called during the meeting, in which all members can participate; the Chair will make clear if and when this applies.
- c) No business shall be transacted at any general meeting unless a quorum is present; 20 voting members shall be a quorum.
- d) Due to coronavirus restrictions the 2020 Annual General Meeting will be held on Microsoft Teams. Parts of the meeting may be recorded; attendees will be notified in advance.
- e) A resolution or election shall be decided by members indicating 'Yes' or 'No' via digital polling software.
- f) An "ordinary resolution" requires a majority vote (taking account only those votes cast in favour as compared with those votes cast against, and (as applicable) the Convenor's casting vote).
- g) A "special resolution" requires 75% or more of the votes cast on the resolution to pass. For the avoidance of doubt, a 75% majority relates only to the number of votes cast in favour of the resolution as compared with the number of votes cast; no account shall be taken of abstentions or members absent from the meeting.
